Buy America/Buy American Guidance*

Buy America, Buy American, Infrastructure Investment and Jobs Act--these are important requirements that can apply to purchasing for federal, state, or municipally funded projects. Sorting out the relationships between these requirements and how they apply to the purchase of Echoflex products can be complex. This document offers information for navigating this process.

Various federal, state, and municipal statutes require "domestic products" be given preference for federal or state funded projects. Requirements can also vary based on who the project owner is and who's providing the funding.

For the most part, Echoflex products are manufactured in the US² and most likely qualify as "domestic <u>products"</u>. The following products are excepted: the O3 product line, various high bay and low bay ceiling occupancy sensors, and enclosed 10Amp relays.

The information below may be able to help you determine whether Echoflex products meet your project requirements. The "domestic product" requirements for US government agency purchases of goods generally apply to contracts that are (i) above the micro-purchase threshold of \$10,000 USD, and (ii) are above the applicable trade agreement threshold³.

- I. <u>Is there an applicable Trade Agreement?</u> If there is an applicable trade agreement, many Echoflex products, except for those listed above, can be considered a domestic US product for the purpose US procurement requirements.
 - Trade agreements may not be applicable if the project involves state or municipal purchases. For those projects, you need to confirm the applicability of any trade agreements with the general contractor prior to submitting your purchase order to Echoflex.
- II. What Government Agency is Providing the Funding? Certain government agencies have their own domestic product requirements: Federal Aviation Administration, Federal Highway Administration, Department of Defense, Federal Transit Administration. The recent Infrastructure Investment and Jobs Act also includes domestic preferences for various public infrastructure and government facility projects⁴. Please review whether your contract receives funds administered by one of these agencies as domestic product requirements may vary.
